Planning

- Equipping and standardizing dialysis ward in hospitals



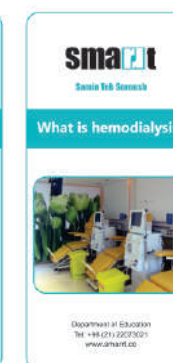
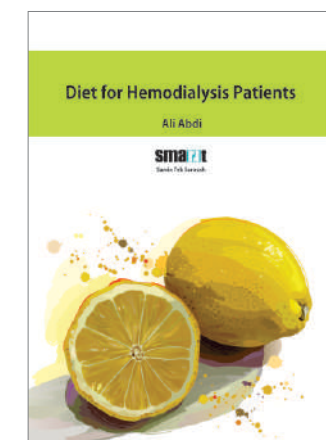
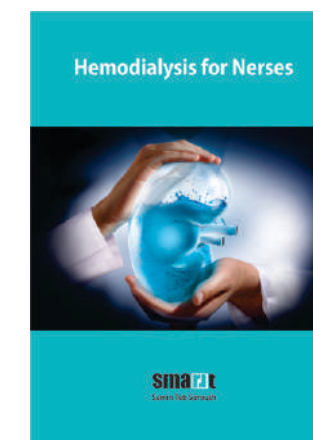
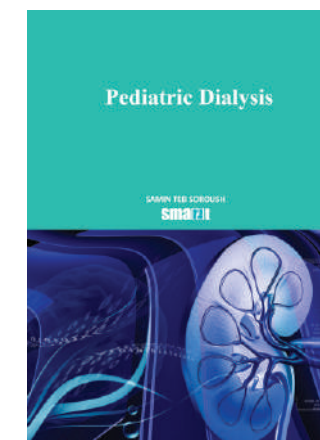


Research

Publications

Smarrt Company has managed to publish educational books, brochures, and translations with the purpose of developing nursing knowledge and ESRD patients' level of general knowledge the distribution of which has indeed been gratifying in medical centers and their desired effects are evident in dialysis centers and patients.



Training

The medical trainings which are offered in medical centers are managed by Smarrt Company. Collaboration Approaches in Project Administration

Three approaches are made use of with regard to projects' development and standardization:

1. Constructing and fully equipping dialysis centers: the company makes an entire investment in creating a management and treatment system in which it manages both the dialysis center and the treatment team.
2. Mutual investment or fixed payment for the construction, renovation, and optimization according to the contract: in this approach depending on either the hospitals' or the doctors' suggestions, the company undertakes various tasks including constructing, equipping, supplying consuming material, maintaining equipment, and last but not least managing the center.
3. Constructing and equipping dialysis centers with the investment of the employer (Turnkey Project): in this approach, the company manages to launch the center, train the personnel, create a management system, and to keep the work going after the construction and delivery. After terminating the construction process, the employer might make use of the services offered by the ICD Group members for supplying high-qualified products, maintenance, and repair services with reasonable prices.

Monitoring and Evaluation

Smarrt Company is monitored by the Ministry of Health and Medical Education at regular intervals. It also requests for further monitoring sessions and regularly evaluates the medical centers which are in its coverage with the equipment at its disposal in order for assessing the physical conditions, environmental hygiene and infection control, maintenance of facilities and equipment performance, management and treatment team, and training and awareness level. In addition to the evaluation of the medical centers in its coverage, Smarrt Co. is capable of evaluating and monitoring other medical centers in concordance with supervising authorities.
